Vendor does hereby understand, acknowledge and agree that Fairplay may cancel Vendor's booth reservation if material terms of this Vendor Agreement are not substantially fulfilled in a timely manner, or in the event of an unforeseeable event beyond the reasonable control of Fairplay, Including, without limitation, acts of nature, fire, explosion, lightning, labor disputes, strikes, acts of terror, epidemics or pandemics, material shortages or unavailability, government laws or regulations, or war or civil disorder (each a "Force Majeure Event"). Should Fairplay deem any term or terms of this Vendor Agreement unfulfilled or in material breach, Fairplay shall give Vendor written notice and Vendor shall have five (5) business days (or such longer time as mutually agreed by the Parties) to cure such breach. Should Vendor cure, this Vendor Agreement shall continue in full force and effect. If Fairplay cancels the Vendor Agreement due to a Force Majeure Event, then (A) Fairplay shall remit to Vendor all deposits less any Vendor Agreement-related expenditure incurred by Fairplay; and (B) all funds provided by Fairplay shall be immediately returned in full. Neither Party shall be liable to the other for any lost profits, lost revenues, consequential or special damages as a result of cancellation.
