



# Fairplay Burro Days 2024



July 26 - 28, 2024 – Fairplay, Colorado

Dear Burro Days Vendor,

We will be celebrating 75 years of Burro Days in 2024 and would love for you to join us! The event will be held Friday through Sunday, July 26 - 28, 2024 in Fairplay, Colorado.

**Booth spaces are reserved with payment only**, and on a “first come, first serve” basis. Please note that we have very limited access to electricity. Electrical outlets will be reserved for vendors that need it to produce their products within their booths and food vendors.

Vendors/exhibitors may set up their booths beginning at Noon on Friday, July 26th. We ask that vendors/exhibitors with space on the lawn set up five feet back from the sidewalk. Hours for all booths will be published as 9.30am – 4pm on Saturday, July 26<sup>th</sup> and Sunday, July 28<sup>th</sup>. **Please do not begin to close down before 4pm on Sunday.** All vendors/exhibitors are asked to leave their area clean after the activities are over on Sunday. Trash cans are provided to dispose of any waste paper and other debris (additional trash bags are available at the Burro Booth). **Please dispose of large pieces of trash in the dumpsters provided. There will also be a cardboard recycling service provided.**

The deadline for all applications and fees is July 10, 2024. You will be notified by email of your assigned booth space upon receipt of your application with payment.

**All fees are non-refundable after July 10, 2024.**

**All vendors** attending Fairplay Burro Days must have a valid/current Colorado Sales Tax license or Multi-Event Sales Tax License if you are selling any products. Licensing information may be obtained on the Colorado Department of Revenue website [www.taxcolorado.com](http://www.taxcolorado.com) or by calling 303-238-7378. Please allow ample processing time for these licenses.

**In addition, ALL** food vendors must have a current retail food license. Park County does not issue temporary food licenses at this time. You must get licensed through the state of Colorado or through another Colorado County. Please call 303-692-3645 or email: [cdphe\\_laponduty@state.co.us](mailto:cdphe_laponduty@state.co.us) to learn more. If you were approved in a prior year, you are still required to apply for the current year. Food vendors and any vendor with animals in their booth must also provide a certificate of insurance.
